ARTICLE 1 WHAT DATA DO WE PROCESS ABOUT YOU?

- 1. FRIENDSHIP INC processes the following personal data from you in the context of its activities:
 - Cookies Each time you surf to our website, we may collect various personal data about you based on cookies and similar technologies, in particular your IP address and surfing behavior. More information about how we use cookies can be found in article 7.
 - Customer data If you use our website or request a service, we may collect the following customer information about you: your name, first name, address, e-mail address, telephone number, company name and VAT number and any other data that you voluntarily provide us.

- Supplier data If you are a (potential) supplier, we process the following data: your name, first name, address, e-mail address, telephone number, VAT number and any other data that you voluntarily provide us.
- Communication data If you call us, email us or contact us through social media (e.g.: LinkedIn), we process the following data: your name, first name, e-mail address, telephone number, the name of your company or employer and any other data that you voluntarily provide us.
- **Job application data -** If you apply for a job with us, we process the following data: your name, first name, address, e-mail address, telephone number, cv, cover letter and any other data that you voluntarily provide us.

ARTICLE 2 WHAT DO WE USE YOUR PERSONAL DATA FOR?

1. General purposes:

We only use your personal data as follows:

- Cookies to maintain and improve our website and to include personal data in statistics, with your explicit, prior consent as a legal basis (except for strictly necessary cookies that do not require consent);
- Customer data to provide the service requested, to contact our customers and to deliver and invoice the services you have ordered and to keep our accounts, based on either the performance of an agreement with you or our legal accounting obligation;
- Supplier data to send you a request for quotation, to place an order, to pay your invoices, to communicate with you and to keep our accounts, based on either the performance of an agreement with you or our legal accounting obligation;
- Communication data to be able to handle your question or request, based on the performance or preparation of an agreement with you if you contact us online or our legitimate interest if you contact us by telephone or our legitimate interest to generate new business in case of contact via LinkedIn;
- **Job application data -** to process your job application based on our legitimate interest in the job application itself and your explicit, prior consent to establish a recruitment reserve;
- 2. Direct marketing:

We also use your personal data for direct marketing, newsletters, promotions, based on our legitimate interest regarding existing customers, the performance of an agreement in case you subscribe to our newsletter or your explicit prior consent in all other cases.

If you no longer wish to receive such communications and would like us to stop processing your personal data for our direct marketing purposes, you can do so at no cost and without having to provide a reason by clicking on the link in each of our direct mailings or by contacting us directly by e-mail or telephone.

ARTICLE 3 WHO RECEIVES YOUR PERSONAL DATA?

- 2. We may use software tools or partners who store your data outside of Europe. We always ensure that our partners handle your data as securely as we do and that your data is just as safe outside Europe as it is here in Europe. More specifically, with Dropbox, Google and LinkedIn we have concluded the Standard Contractual Clauses made available by the European Commission and we provide individual additional guarantees on top of these Standard Contractual Clauses wherever necessary and possible.
- 3. If we ever stop or transfer our activities to someone else, for example because we go bankrupt or sell our activities, this can mean that your personal data will be transferred to third parties who will take over our activities in whole or in part. inform you in advance as far as possible, but you understand that this is not technically or commercially feasible under all circumstances.

ARTICLE 4 HOW LONG DO WE KEEP YOUR PERSONAL DATA?

We keep your personal data as long as this is necessary to achieve the purposes of each processing activity:

- We keep customer and supplier data for a maximum of 5 years after the end of the collaboration. Certain data we are obliged to keep for 7 or 10 years due to the legal accounting obligation;
- We keep communication data for a maximum of 1 year if no collaboration is established and a maximum of 5 years if there is a collaboration;
- We keep job application data as long as the job application procedure runs and for a maximum of 1 year afterwards if you have consented to a recruitment reserve;
- We keep emailings to existing clients for 2 years after the last contact, unless you indicate that you no longer wish to receive such emailings.

ARTICLE 5 YOUR RIGHTS

You have the right to access your personal data and the use we make of it free of charge at any time. You have the right to ask us to correct, supplement or delete your personal data. In a number of cases listed in the GDPR, you may also request to restrict the processing of your personal data. You have the right to object to the processing of your personal data if you have serious and legitimate reasons for doing so that go beyond our need to process your data. You also always have the right to object to the use of personal data for direct marketing purposes, even without having to provide a reason. You have the right to request your personal data in digital and readable form and / or to have it transferred to another service provider of your choice. Insofar as our processing is based on your prior consent, you have the right to withdraw that consent.
